Introduction

The aim of this document is to provide guidance on the prescribing of specials on FP10 within Dermatology in primary care.

The guidelines have been developed for use across Gateshead, South Tyneside and Sunderland CCGs. A consistent approach is needed across the primary care to ensure that there is no confusion for secondary care services, no inequalities in the provision of services and that cost-effectiveness of prescribing is maintained.

Aims

- To review current prescribing across South of Tyne & Wear localities in line with The British Association of Dermatologists specialist booklet (BAD 2008)
- To agree a list of Dermatology Specials prescribed by specialists in both primary and secondary care.
- To consider recommendations to use the most cost-effective manufacturers of specials wherever possible.

Note:

GPs are advised that dermatological specials not listed in this guidance or the British Association of Dermatology (BAD) list http://www.bad.org.uk//site/1284/default.aspx should be considered as RED and should not be prescribed in primary care.

SOTW List of Dermatological Specials for prescribing in Primary Care on FP10

Please consider the following before prescribing a Dermatological Special on FP10:

Where a proprietary product exists, this should be used in preference to a special, such as for:

- Menthol in aqueous cream
- Lassar's paste (zinc and salicylic acid paste BP)
- Formaldehyde
- Dithranol

Dermatological Specials are only indicated in specific circumstances. They are not indicated for routine use:

• Dermatological Specials should not be initiated other than on the authority of a Consultant Dermatologist or a GP with a Special Interest in Dermatology.

Prescribe the Special as an acute prescription not a repeat:

- Most of the Dermatological Specials included on the SOTW list are indicated for short-term use only.
- Treatment should be stepped down to proprietary products once flare-ups are controlled.
- Patients should be reviewed regularly to identify continued need for prescribing of dermatology medicine (see below).

For coal tar preparations – ensure that the correct formulation is requested:

As written on prescription	Type of coal tar used
Coal tar 6% in YSP	Crude coal tar
Coal tar solution 6% in YSP	Alcoholic solution of crude coal tar – 1 in 12 dilution
Coal tar solution strong 6% in YSP	Alcoholic solution of crude coal tar – 1 in 6 dilution

Consider specifying the manufacturer on the FP10 prescription:

- Most Dermatological Specials can be procured at a much lower price than that usually paid by primary care if they are procured from certain suppliers who routinely produce large volumes of these specials.
- It is recommended that wherever possible community pharmacies order specials from the special manufacturers that provide the most cost-effective specials.

Regularly review the need for any Dermatological Special prescribed on repeat.

- Most of the Dermatological Specials included on the SOTW list are indicated for short-term use only.
- Treatment should be stepped down to proprietary products once flare-ups are controlled.
- If the Dermatological Special seems to be being used regularly or frequently, invite the patient for a review appointment with a view to discussing stepping down or refer to Dermatology for a review.
